

"Why Did I Do That...Again?!-Adversity's Impact on Coping Strategies and How to Develop Healthier ones."

Elizabeth Dunn, MS, LPC, NMT Phase II Certified 1:00 pm - 5:00 pm

Dr. Bruce Perry's work on the effects of adversity, neglect and trauma on brain development provides the framework for understanding a range of unhealthy and unacceptable behaviors that often lead to non-compliance with court plans. In taking the "What Happened to You" approach, Dr. Perry and his team have demonstrated improvement in behavioral and relational interactions across settings such as residential treatment, juvenile detention, group homes, school districts, foster placements and adult correctional facilities. This workshop provides an introduction to Dr. Perry's research on directly applying the critical skills of regulation and relationship to foster successful interactions and plans with people struggling with managing their lives with adversity-informed coping skills. Generational and cultural adversity play a significant role in an individual's ability to self-regulate, to trust systemic interactions and to navigate with systems. These concepts are embedded throughout the workshop as they often play a key role in how a client will succeed or struggle as they interact with the court system. Participants will explore and be invited to engage in brief, "hands-on" regulating activities designed to boost cognitive functioning skills when working with stressed individuals.



### Plenary

Helping the Herd, Polyvagal Principles, and a New Paradigm for Working with Complex Cases

Rebecca Bailey, PhD 8:30 am - 10:00 am

This presentation is intended to introduce the application of polyvagal principles to high-conflict families and systems. The polyvagal principles will be incorporated by introducing an approach that looks at the interplay of multiple nervous systems and their impact on resolution. In addition, alternatives to traditional talk therapy will be introduced such as walk-and-talk therapy and equine-assisted interventions. The rationale for the interventions will be introduced as well as possible alternative hypothesizes for adaptive behaviors.

Dr. Bailey is considered a nationally recognized expert in non-familial and familial abductions. Dr. Bailey is also a regular consultant referral for the National Center for Missing and Exploited Children and the Federal Bureau of Investigation. She has been a guest and commentator on Anderson Cooper, Good Morning America, Piers Morgan, Erin Burnett, Kyra Phillips, 20/20, Diane Sawyer, Dr. Oz and World News Tonight. In 2013, she co-authored the book Safe Kids, Smart Parents (Simon Schuster).

There is substantial support in the literature for the need to work through issues, not avoid them, as a prerequisite to healthy relationships.

Presenters from diverse legal and behavioral health professions will discuss realistic fact patterns that overlap roles and issues potentially impacting the ethical conduct of the individual professional. # Ethics for Mental Health Providers Faren Akins, PhD, JD, Barb Kiffmeyer, LMSW, and Sid Buckman, MA

The focus of the workshop is how to approach, analyze, address, and resolve ethical problems encountered in the forensic arena. The presenters will provide complex fact patterns involving ethical issues from their respective practices. Audience members will be asked for input at certain decision points leading to interactive discussions. Presenters will follow up with thoughts, suggestions, and analysis.

### Ethics for Legal Professionals

Maret Vessella, Chief Bar Counsel State Bar of Arizona

The presentation will cover an overview of lawyer regulation and what happens in a year, including the number of charges received, who is likely to file a charge and the most common concerns expressed in those charges. The presentation will also cover professionalism requirements and when a breach of professionalism can result in a disciplinary sanction. The presentation will highlight some relevant cases that demonstrate unprofessional conduct that has been sanctioned. Additionally, the presentation will include when judges should refer lawyers to the State Bar and some options to address lawyer conduct in the courtroom. The presentation will also highlight some more recent family law cases to illustrate the type of conduct that may result in a disciplinary sanction.

# Ethics for Mediators Andrew B. Turk, JD

This program will discuss basic ethical issues that every mediator should be prepared to address in order to protect the mediation process. Topics of discussion include Conflict Disclosures, Engagement Letters, Confidential vs. Non-Confidential Memoranda, Challenges of Virtual Mediations, and Interpretation of A.R.S. § 12-2238. The session will end with a question and answer period and audience participation will be encouraged throughout.
